Goal 1: Early Childhood Literacy

The percent of 3rd grade students that score Meets Grade Level or above on STAAR Reading will increase from 38% to 46% by June 2024.

Goal 2: Early Childhood Mathematics


The percent of 3rd grade students that score Meets Grade Level or above on STAAR Math will increase from 59% to 67% by June 2024.

Goal 3: College, Career, and Military Readiness

➤ The percent of graduates that meet College, Career and Military (CCMR) criteria will increase from 68% to 75% by July 2024.


Grade 3 STAAR Reading at the Meets Grade Level Standard or Above

Goal 1: Supporting Data


STAAR Reading/English Language Arts Meets Grade Level Standard

- Reading performance in grades 3 and 4 were impacted more from COVID (and virtual instruction) than higher grades.
- English I performance at the Meets Grade Level Standard increased from 2019 to 2021.

Goal 2: Early Childhood Mathematics




Goal 2: Supporting Data

STAAR Mathematices/Algebra I Meets Grade Level Standard



- Percentages shown reflect all students tested on the STAAR English assessment.
- Math performance in grades 3, 5, and Algebra I were impacted more from COVID (and virtual instruction) than other grades.
- In 2019, math performance exceeded reading performance. In 2021, the reverse was true.


Goal 3: College, Career, and Military Readiness



- Percentages for 2018 and 2019 graduates include points for CTE course completion.
- The rate for 2020 graduates excludes the extra points due to a change in state calculations.
- 2021 data for the 2020 graduates Did Not Meet Target.
- 2022 targets will be readjusted to reflect the change in state calculations.
